### President's Message By Barbara A. Field, FAIA

It is my honor to serve as the Board of Architecture president for 2010-2011. My first license to practice was issued in 1970 by the Georgia Board of Architecture. I've served on North Carolina Board of Architecture since 2004. I was the first

woman to graduate with a Bachelor of Architecture degree from Georgia Tech in 1965. I have worked for John Portman, FAIA in Atlanta, GA, John M. Johansen, FAIA in New Canaan, CT, Benjamin Thompson, FAIA in Cambridge, MA. Before opening my own practice in 2005, I was Director of Design for SPACEPLAN Architects in Asheville, NC.

During my tenure as Board President, the Board will act on several important issues that affect the practice of architecture, as it relates to the health, safety and welfare of the public. The Board is moving forward on rule updates that are more reflective of the practice as it is today. A list of the proposed rule changes is found on the Board home page at <a href="www.ncbarch.org">www.ncbarch.org</a>. In summary the rule updates will add some definitions to the administrative code, clarify language related to firm practice and also update administrative, practice and exam procedures.

A popular section of the newsletter is the Enforcement Report. As a member of the Professional Standards Committee (PSC) for the past few years I've had the opportunity to see firsthand the cases that come before the Board. Some believe that challenging ethical dilemmas are not common for the professional licensee. As members of the PSC, we regularly review in great dept the allegations and investigations of wrongdoing – both incompetence and unethical actions by architects as well as non-licensed practice. While some cases must be dismissed due a lack of evidence of wrongdoing, we often find through the course of an investigation that there are more violations than originally alleged in a complaint.

To ascertain if violations have occurred there is a thorough process of investigation and review by the PSC prior to determining the violation or even if a violation has occurred. Investigations, thresholds for violations and types of discipline are outlined in the Board laws and rules. We think long and hard about disciplining our peers and are careful to investigate every matter thoroughly. Please know that we are prohibited by law from getting involved in contractual issues unless there is some violation of our statutes or rules involved. We have what we believe to be a very fair process for dealing with complaints against architects but this process takes time. Don't expect instantaneous decisions from us.

Lately, there has been, within the profession an increase in allegations of unethical practices by architects. This may be a result of the lean times in the construction industry, most especially for architects. Often we find that there architects who just didn't see the situation as an ethical dilemma. They made the wrong choice – in an effort to save business or put food on the table - without thinking of the issue from a different perspective. Nonetheless, there are plenty of architects who most likely knowingly made a wrong choice. Therefore, I urge you to review the rules and laws of the Board and contact the Board staff whenever you may have questions regarding a decision that may put your license in jeopardy. Our staff is experienced and knowledgeable and they stand ready to help you—often they will see things from a different perspective and offer fresh insight upon which you can make reasoned decisions.

I look forward to serving the architectural community this coming year and working to assure the heath, safety and welfare of the public



#### **IDP Notes**

As of July 1, 2010, all interns who established an NCARB record before July 1, 2009, are required to submit training hours in six-month reporting periods and within two months of completion of each reporting period. The pros and cons of this have been debated for quite a while. But in the end the rule will facilitate better and timelier communication between interns and IDP supervisors. It will also allow for up to date feedback on an interns progress in the profession and identify areas where they may need more experience.

New and updated to capture your IDP training hours, the IDP Workbook is designed to simplify reporting IDP experience. The IDP Workbook uses an Excel spreadsheet format for recording training hours on a daily basis. The workbook cumulatively tracks time daily, weekly, and multi-weekly. This provides an at-a-glance way for interns and their supervisors to assess strong and weak training areas in addition to the tools in the e-EVR.

#### **NCARB** Publications

NCARB has a library of webcasts and podcasts developed to help interns and architects understand and stay up to date on the latest developments and rules affecting NCARB programs.

Also found in the library is the IDP Supervisor E-News. This newsletter is designed to provide tips for successful supervising and resources that will assist both supervisors and their interns to navigate the program.

# enforcement report

Following is the Enforcement Report for the period September 1, 2009 through July 16, 2010. The Board is not bound by precedence in matters of disciplinary action. It is the prerogative of the Board to be conservative in its review of cases and to enforce the rules and laws with sanctions and civil penalties as allowed by law. #### CEASE AND DESIST

A cease and desist order was issued to Betsy Clark and Timothy Donohue of Diamondwater, LLP (Case 854) for the non-licensed practice of architecture.

#### Letters of Caution

The Board closed six cases with a letter of caution issued to architects licensed in North Carolina. A letter of caution is a non-disciplinary, non-published action.

#### Dismissed/Unfounded

The Board of architecture dismissed five cases as unfounded.

#### **Consent Orders**

The Board closed ten cases with Consent Orders, they are as follows:

Case 851 – Eric Townson, Respondent

- 1. Respondent is licensed as an architect by this Board and is subject to Chapter 83A of the General Statutes of North Carolina and Title 21, Chapter 2 of the North Carolina Administrative Code.
- 2. Respondent was engaged to provide a design for a retaining wall in excess of 11' high for a project located at 1164 W. U.S. 64, Murphy, NC. The wall in question, failed. Wall failure places the public in harm's way.
- 3. Respondent has not provided adequate evidence demonstrating his ability to properly design such retaining walls.
- 4. Respondent contends that he did not intentionally violate any Board rules and laws but wishes to resolve this matter by Consent and agrees that the Board staff and counsel may discuss this Order with the Board ex parte whether or not the Board accepts this Order as written.
- 5. The conduct described in paragraphs 2-4 above constitutes violations of 21 NCAC 02.0209 and 21 NCAC 2.0210. Based on the foregoing and in lieu of further proceedings under 21 N.C.A.C. Chapter 2, Section .0600, the Board and respondent agree to the following:

Respondent is reprimanded. Respondent shall not offer or render any type of professional engineering services, including, but not limited to, design of retaining walls, regardless of size and scope, or material until such time as he receives an appropriate license from the North Carolina Board of Examiners for Engineers.

#### Case 866 – Richard Wordell, Respondent

Respondent is licensed as an architect by this Board and is subject to Chapter 83A of the General Statutes of North Carolina and Title 21, Chapter 2 of the North Carolina Administrative Code

Respondent was randomly selected to be audited pursuant to Board Rule 21 NCAC 02.0904(e) for compliance with continuing education requirements for calendar year 2008; and,

Respondent certified on the 2009-2010 License Renewal for Individual Registration that he complied with the North Carolina Rules and Laws governing continuing education for the 2008 calendar year, and,

Respondent certified on the 2009-2010 License Renewal for Individual Registration that he read the North Carolina Architectural Laws and Rules, and,

Respondent did not claim an exemption from North Carolina's continuing education requirements and failed to adequately substantiate the verification of compliance with the continuing education requirements for 2008;

Respondent has provided a log of his Continuing Education for the time period January 1, 2008 through December 31, 2009. During this period, despite certifying on the 2009-2010 renewal form that he complied with the rules and laws that govern Continuing Education, Respondent failed to obtain the required contact hours for 2008. Additionally, Respondent failed to obtain required contact hours for 2009.

Respondent wishes to resolve this matter by consent and agrees that the Board staff and counsel may discuss this Order with the Board ex parte, whether or not the Board accepts this Order as written.

BASED upon the foregoing, the Board makes the following Conclusions of Law:

Respondent is subject to the provisions of Chapter 83A of the North Carolina General Statutes (N.C.G.S) and Title 21, Chapter 2 of the North Carolina Administrative Code (N.C.A.C.), including the Rules of Professional Ethics and Conduct promulgated and adopted therein by the Board.

#### Case 866—Wordell, continued

Respondent's conduct as set out above constitutes a violation of NCGS Chapter 83A and 21 NCAC 02.900 and 21 NCAC 0209 (10).

In lieu of further disciplinary proceedings the Board and Respondent agree to the following Order:

Respondent shall complete earning all health, safety and welfare contact hours necessary to fulfill the number of hours of North Carolina continuing education contact hours required for the calendar year 2008 and 2009, totaling 7.5 contact hours by June 30, 2010; and.

Respondent shall complete twelve additional contact hours for the 2010 calendar by December 31, 2010.

Respondent shall be on probation until December 21, 2012; if Respondent violates any of North Carolina's architecture laws and rules during the period of probation, the North Carolina Board of Architecture may suspend the Respondent's license for 30 days in addition to any other discipline found by the Board to be appropriate for said violation; and,

Respondent will reimburse the Board for all administrative costs associated with this action.

Respondent is reprimanded.

#### Case 835 – Thomas Incze, Respondent

Respondent is licensed as an architect by this Board.

Respondent was engaged to prepare design plans for Gethsemane Baptist Church, Charlotte, North Carolina.

The plans for the project were subsequently sealed by Respondent and submitted for permit to the City of Mecklenburg Building Inspections Department.

The design drawings sealed by Respondent included structural engineering plans, work generally requiring engineering education, training and experience, as those terms are used in N.C.G.S. 89C-3(6)a.

Respondent is not duly licensed and registered as a Professional Engineer by the North Carolina Board of Examiners for Engineers and Surveyors.

In the preparation of the structural engineering plans, Respondent failed to adequately demonstrate competence in sizing structural members and the calculations for the structural members appear to have been prepared after the fact of design.

Respondent wishes to resolve this matter by Consent and agrees that the Board staff and legal counsel may discuss this Order with the Board ex parte whether or not the Board accepts this Order as written.

#### **CONCLUSIONS OF LAW**

The Board has jurisdiction over this matter and over Respondent and he is therefore subject to Chapter 83A of the General Statutes of North Carolina and Title 21, Chapter 2 of the North Carolina Administrative Code.

The acts and omissions described above constitute violations of N.C.G.S. § 83A-15(3) and 21 NCAC 2.0210.

BASED on the foregoing and in lieu of further proceedings under 21 NCAC 2 .0600, the Board and Respondent stipulate and agree to the following:

Respondent is reprimanded.

Respondent shall not seal engineering plans for any future projects for which he is engaged to provide architectural services until such time as he receives an appropriate license from the North Carolina State Board of Registration for Engineers and Land Surveyors.

#### Case 853 - Laurent de Comarmond

Respondent has applied for licensure by reciprocity based on NCARB certification and is subject to Chapter 83A of the General Statutes of North Carolina and Title 21, Chapter 2 of the North Carolina Administrative Code.

Respondent de Comarmond indicated that he has offered and rendered architectural services and used the title architect while employed with JDavis Architects and KlingStubbins.

Respondent indicated that he has used the title 'architect' while working in the State of North Carolina for at least five years. Respondent's action in using the title architect prior to licensure in this state is a violation of North Carolina General Statue 83A-1 (1) and 83A-12.

Respondent wishes to resolve this matter by Consent and agrees that the Board staff and counsel may discuss this Order with the Board ex parte whether or not the Board accepts this Order as written.

BASED on the foregoing and in lieu of further proceedings under 21 N.C.A.C. Chapter 2, Section .0600, the Board and respondent agree to the following:

Respondent shall be issued a license to practice architecture in the State of North Carolina.

Respondent shall reimburse the North Carolina Board of Architecture for administrative fees associated with this Consent Order. Respondent shall pay a Civil Penalty in the amount of \$250.00

The following firms offered and rendered architectural services prior to licensure. As a result, they entered in to Consent Orders with the Board of Architecture. The Consent Order they receive is standard disciplinary action for firms and individuals who fail to obtain proper licensure prior to offering and rendering services. The dollar amount indicates the Civil Penalty paid. Civil Penalties are not retained by the Board but are forwarded to the State Treasurer for disbursement to the school board for the county in which the violation took place. Board administrative costs and renewal fees were also recovered when appropriate.

Case 865 - Roger Swanson and Anshen & Allen Architects, Inc. Respondents: \$3000 Civil Penalty
