

## board happenings

#### PRESIDENT'S MESSAGE CONTINUED

#### **NCARB Leadership Transition**

NCARB has selected Michael J. Armstrong, currently a senior vice president at the International Code Council (ICC), as its next chief executive officer, effective June 2011. Armstrong has spent over two decades in executive roles in nonprofit, government, and for-profit organizations. During his four years at ICC, Armstrong's leadership has included oversight of their testing and certification programs, along with the administration of various activities ranging from communications and marketing to membership, chapter relations, and continuing education.

"The Search Committee was immediately impressed with the breadth of Mike's experience in a variety of settings, his adaptability to different audiences, and the ease and confidence in which he presented himself," said NCARB President/Chair of the Board Kenneth J. Naylor, AIA, NCARB, LEED AP. "He's a personable, engaging professional with excellent executive credentials to take NCARB to the next level."

The CEO position of NCARB is the primary executive staff position, reporting directly to the Board of Directors. In it Armstrong will have overall responsibility for leadership and management of the organization, in partnership with the president and the Board. The North Carolina Board of Architecture welcomes Michael J. Armstrong and looks forward to working with him.

#### SB 435 Certificate of Merit By Charles H. Boney, Jr. FAIA,

I met last week with Senator Thom Goolsby (New Hanover) at his invitation to discuss SB 435, which would require a Certificate of Merit to accompany a lawsuit filed against an architect or engineer. The bill was introduced by Senator Hartsell (Cabarrus, Iredell), and is now pending in a committee that is vice-chaired by Senator Goolsby.

In concept, the Certificate of Merit is a statement by another architect or engineer who has considered the allegations and agrees that the lawsuit has merit. Architects provide a certificate for cases against architects, engineers for engineers.

It was an interesting discussion attended by four other architects. After the requisite period of lawyer jokes and complaints about the economy, we was were able to arrive at a mutual understanding and support of the idea. We agreed that the bill would reduce the number of frivolous lawsuits, while giving professional support to those cases that have merit.

An unintended consequence of the Certificate of Merit is that it the Board of Architecture would expect an architect filing the Certificate of Merit to also notify the Board under the requirements of Rule 21 NCAC 02.0208 (d), which states:

"Knowledge of Violation. An architect possessing knowledge of a violation of these Rules by another architect shall report such a violation to the Board." The bill would also give the Board authority to discipline architects who certify an action that is without merit by amending NC General Statute 83A-6.

The State has charged the Board of Architecture with the protection of the public by monitoring the profession of Architecture. In my opinion, this bill will also help protect architects from abuse in our court system. ## NCARB news

#### **New Prometric Exam Security Process**

NCARB has been informed by its testing consultant, Prometric, that it will be implementing additional security procedures at the test centers. As a result of a pilot program conducted in 2010, Prometric has decided to deploy hand-held metal detectors to all Prometric testing centers in the United States by mid-June 2011.

This new policy is summarized as follows:

- All candidates will be scanned by a hand-held metal detector prior to each entry into the testing room, including returns from breaks;
- All candidates will be required to submit to the scans, with few exceptions; and
- Candidates refusing to be scanned may not be permitted to test.

Please be aware of and prepared for this change at upcoming testing appointments.

#### Tips on how to develop a plan to get licensed by the architects who work at NCARB

Washington, DC—The National Council of Architectural Registration Boards (NCARB) has launched a new video series entitled "NCARB Talks," featuring short, informal conversations with architects on staff. These videos give viewers a glimpse of individual triumphs and challenges on the path to licensure. They discuss their experiences with the Intern Development Program (IDP), the Architect Registration Examination® (ARE®), and the importance of getting licensed and ultimately NCARB certified.

Whether you are a student considering the profession, or are an intern currently in the process of becoming licensed, this series provides insight into the licensure process. These videos are also a resource to illustrate the realities of the profession for those mentoring the next generation of architects.

In addition to the hundreds of volunteer architects from the 54 U.S. registration boards who work to contribute to the development of NCARB's programs, there are many architects on staff in its Washington, DC office. As is typical in the profession, each of these individuals had their own unique plan to earn their license to practice architecture.

The "NCARB Talks" series will first feature Assistant Director, ARE Development Jared Zurn, AIA, NCARB, and Manager, IDP Martin Smith, AIA, NCARB, LEED Green Associate. For Zurn, the driving factor in seeking his license was independence—he knew that if he became licensed, he really had more opportunities. While for Smith, getting to licensure was about discovering his passion for the profession. #### Consent Judgment—Reprint from previous newsletter.

Case 869 - Paul Stafford

A Consent Judgment for Injunctive Relief was granted in Wake County Superior Court by Judge Gessner to the Board of Architecture in the matter of Paul Stafford. A Final Agency Decision was issued in November 2009 revoking Stafford's license to practice architecture. Despite the Final Agency Decision it was determined that Stafford continued to offer and render architectural services. Stafford placed the seal of another architect on the project plans and made himself the agent for the project. Stafford, via Consent Judgment, was permanently enjoined from the practice of architecture. Any violation of this Judgment shall be deemed contempt of court and shall be punishable by both the civil and criminal contempt powers of the Court upon proper showing.
