### President's Message By Barbara A. Field, FAIA

The members of the North Carolina Board of Architecture attended the National Council of Architecture Registration Boards (NCARB) Annual Meeting in Washington, DC. Several changes took place

allowing advancement the of the Council's activities and services to its certificate holders. Below are some highlights of the meeting:

-A resolution modifying NCARB's Model Law regarding Continuing Education was passed. The new Model Law requires 12 hours of HSW Continuing Education with a calendar reporting year of January 1<sup>st</sup> to December 31<sup>st</sup> and no carry-over of hours is allowed. Fortunately, the North Carolina rules regarding Continuing Education mirror the new model law so we won't have to make any rule changes. With the assumption that other jurisdictions will adopt Model Law; this will vastly simplify the numerous reporting periods and hourly requirements that now exist among the states. NCARB is working with AIA to negotiate an agreement on Continuing Education requirements between the two organizations.

-NCARB also has a new Chief Executive Officer (CEO). Mike Armstrong of Washington, DC assumed the leadership of the Council as of July 1, 2011. See the article about Mike in the NCARB Happenings section of this Newsletter. In June, Lenore M. Lucey, FAIA, NCARB, retired from her position as CEO. She was a dedicated and diligent leader for NCARB for fourteen years.

-We also have new leadership within Region 3 – The Southern Conference of NCARB represents Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North Carolina, Puerto Rico, South Carolina, Tennessee, Texas, and the U.S. Virgin Islands.



<u>A reminder for all owners of registered firms</u> – Firm renewal forms for 2012 will be mailed to all currently licensed firms in mid October. Please look for the form to arrive via U.S. Mail. This should not be confused with your individual license renewal. Firm licenses must be renewed by December 31, 2011 or the license will expire. Please be sure to send any 'snail' mail FIRM address changes immediately. An address change form is in the forms section of the Board web site. **Expired license listing** – In the back of the newsletter you will find a list of all individuals whose North Carolina license to practice architecture expired on June 30, 2011. This list includes individuals who, for various reasons, chose not to renew and notified the Board office. If you find yourself (or an associate) on the list and you are currently practicing architecture in this State, you may be in violation of Board rules and laws and may be subject to disciplinary action. If you feel that you are on this list in error, contact Cathe Evans or Julie Piatek immediately. You may renew your license on-line or download a 2011-2012 renewal form from the forms section at <a href="https://www.ncbarch.org">www.ncbarch.org</a>

<u>Have you done your Continuing Education?</u> In order to renew your license for 2012-2013 next year you must be able to certify on your renewal that you completed twelve contact hours of HSW related continuing education during the 2011 calendar year. This means that you must complete the hours by December 31, 2011. The Board rules regarding continuing education are found in the rules and laws section of <a href="www.ncbarch.org">www.ncbarch.org</a>. Specifically, the CE rule is outlined in 21 NCAC 02 .0900. You are responsible for recording your CE, the Board does not do this for you. <u>The Board of Architecture will hold</u> its annual New Architect Luncheon in November at the Center for Architecture and Design (CfAD). If you were licensed by exam in the past year, you will receive an invitation very soon.

## NCARB news



## Michael J. Armstrong Assumes the Role of NCARB Chief Executive Officer

Washington, DC—Michael J. Armstrong assumed the role as the chief executive officer (CEO) of the National Council of Architectural Registration Boards (NCARB) at its 92nd Annual Meeting and Conference. In his address to the Council's membership, Armstrong expressed his passion for architecture and noted his engagement with the built environment throughout his career. He pledged a new chapter in the NCARB story—one that will include the Council achieving "new heights on behalf of the nation's health, safety, and welfare."

"While a good foundation is essential to the safety and livability of any structure, it is only the starting point," said Armstrong. He credited the NCARB Board of Directors and the legacy of the outgoing CEO Lenore Lucey with achieving monumental change and

positioning the Council for the future.

Armstrong noted NCARB's Strategic Plan and its importance in determining the Council's direction. "Successful implementation of the Strategic Plan, in large degree, rests upon our capacity to relate and communicate," said Armstrong. "We plan to implement this with great vigor, believing that it delivers a necessary package of benefits to the practice, economy, and reputation of the architecture community."

The twin goals of outreach and collaboration have defined Armstrong's professional life. The tenor of his leadership will be "to listen closely and dialogue intensely... and work to build relationships."

Armstrong brings a depth of experience to the Council including more than two decades in executive roles in nonprofit, government, and for-profit organizations. He most recently served as the senior vice president for membership and outreach services at the International Code Council (ICC).

# NCARB Board of Directors Examines Strategic Long-range Issues, Approves Revised Budget for Practice Analysis Survey, and Takes Action on ARE Security Breach

- The BOD authorized funding for the next ARE vendor contracts that will continue the momentum toward an enhanced candidate-and-member friendly experience, and will introduce tools for exam development and management in late 2013.
- The BOD approved a revised budget for the Practice Analysis of Architecture Survey. The practice analysis is developed to gather the data needed for future evaluation of and changes to the ARE, IDP, CE, and NCARB's contribution to the 2013 NAAB Accreditation Review Conference. The survey will be sent out in April 2012 to interns, architects, and educators.
- Report on the AIA/NCARB Leadership Retreat President Veazey reported that there was great synergy at the meeting with the leadership from both organizations. A collaborative atmosphere characterized the meeting where the Practice Analysis, IDP, and the CE/Model Law change were discussed. Both organizations committed to a continuity of effort in the future.
- ARE Security The BOD voted to suspend a candidate's ARE test-taking privileges for a period of two years for suspicious activity with a reservation of the right to take additional disciplinary action if further evidence reveals that the candidate disclosed test content to others.
- The BOD voted to adopt revised Policy and Procedures for Testing Irregularities submitted by the Committee on Professional Conduct.

The NCARB BOD meets next in December 2011.

# enforcement report

Following is the Enforcement Report for the period June 1, 2011 to August 30, 2011 The Board is not bound by precedence in matters of disciplinary action. It is the prerogative of the Board to be conservative in its review of cases and to enforce the rules and laws with sanctions and civil penalties as allowed by law. ### **Consent Order**

Case 901 – Slattery, John Joseph/Practice Evolutions, LLC

Respondent Slattery as a consultant to Practice Evolutions, LLC, offered architectural services as defined in Chapter 83A of the General Statutes of North Carolina for projects to be constructed in North Carolina. Practice Evolutions, LLC is not licensed to practice architecture in the state of North Carolina. Slattery offered the services as a sole-proprietor using the fictitious name Architecture Evolutions.

Respondent Slattery is not currently registered with this Board to offer and render architectural services in North Carolina. Respondent, on June 10, 2011, submitted an Application for Licensure by Reciprocity. Respondent's action in practicing architecture prior to licensure with this Board is a violation of G.S. 83A-1 and G.S. 83A-12. Slattery contends that he did not intentionally violate North Carolina's Architecture Rules and Laws. Nevertheless, in lieu of further proceedings, Slattery has agreed to enter in to this Consent Order. BASED on the foregoing and in lieu of further proceedings under 21 N.C.A.C. Chapter 2, Section .0600, the Board and respondent agree to the following:

Respondent Slattery shall, within thirty (30) days from the date this Order is approved by the Board, complete the individual licensure process. Respondent shall pay a civil penalty in the amount of \$500 for practicing architecture prior to licensure. Respondent shall pay a previously agreed upon amount of the Board's administrative costs incurred as a result of this matter. Respondent Slattery is reprimanded.

### **Consent Judgment**

Case 882 – Harmon, James

The Board of Architecture closed one case with a Consent Judgment. On June 14, 2011 Judge Howard Manning signed an order filed in the Wake County Superior Court prohibiting James Harmon/Crescent Design-Build, Inc./Arterra Properties, Inc. from practicing architecture as defined in G.S. 83A. Mr. Harmon does not hold a license to practice architecture. For a copy of the full Consent Judgment contact Cathe Evans and reference Case 882.

### Letter of Warning

The Board of Architecture issued one Letter of Warning to R. Brian Price of Stone Cottage Designworks.

### Dismissed/Unfounded

The Board of architecture dismissed one case as unfounded.

### Cease and Desist Orders

The Board issued one Cease and Desist Order to Marcel Goneau and Jesse Dishner for practicing under the name Goneau Dishner Construction/Architecture. Neither Goneau nor Dishner hold a license to practice architecture.

# expired license report

The Board announced on several occasions that in an effort to be environmentally and fiscally responsible, notice of renewal will be sent via email. By mid May 2011 there were only 25 individuals (out of approximately 5400 licensees) who did not have an email on file with the Board, as a courtesy, we sent those individuals a final paper notice by U.S. Mail. We understand that some of you do not like to renew your license on line, while we will continue to send the notice of renewal via email, we give you the option to download a form from the forms section of the Board web site and pay with a personal check using the postal service.

As indicated in the report from the Executive Director, following you will find a list of individuals whose license expired on June 30, 2011. The first notice of renewal was sent on May 15, 2011 via EMAIL only to the email address as on file with the Board. A second notice was sent, also via email on June 30, 2011. Kathie Rainey of the NC-AIA, as a courtesy, followed up with her members who had not renewed in a timely manner. In some cases individuals on the list were given four notices of renewal. Please note that if you are the individual architect in your firm who is the qualifying officer, shareholder and director, and your individual license is not current, the firm license may have been revoked. As a licensed professional, you are responsible for maintaining your license and renewing on time.
