**Application for a Foreign Corporation for a Certificate of Registration to Practice
 Architecture in the State of North Carolina - FEE \$75.00-**

Information and Instructions

- Fill out application completely and return to the North Carolina Board of Architecture at the above address.
- The application fee is \$75.00. Check should be made payable to NCBA and attached to this application.
- Attach to the application a copy of the Articles of Incorporation and any Amendments thereto as filed in the firm home State.
- After a review of the application the Executive Director will issue the Board's Certificate for Filing. It must be affixed to the Application for Certificate of Authority and filed with the North Carolina Secretary of State, Corporations Division, PO Box 29622, Raleigh, North Carolina 27626-0622. SOS-Corporations Division Phone: (919) 807-2225. ***The Certificate for Filing as issued by the Board of Architecture and the Certificate of Authority as issued by the Secretary of State are necessary documents that lead to firm licensure, they do not permit a firm to offer or render architectural services.***
- You will receive from the North Carolina Secretary of State a Certificate of Authority. Make a copy of that document and send it to the Board of Architecture office. Upon receipt a Certificate of Registration (license) will be issued to the firm. The firm shall then be entitled to offer and render architectural services in the State of North Carolina.
- The Name of the Corporation must have a corporate designation. If the firm name as used in its home state does not have that a designation such as Inc., P.C. P.A. or Ltd. a "Doing Business As" name must be used in North Carolina. For example Doe Architecture d/b/a Doe Architecture, Inc.
- All correspondence from the Board will be sent via E-Mail.
