THIS CAUSE, coming before the North Carolina Board of Architecture and Registered Interior Designers in its offices at 434 Fayetteville St Suite 2005, Raleigh, Wake County, North Carolina, with a quorum present. The Board and Respondent agreed to entry of the following Consent Order.

1. Emily York applied for licensure by reciprocity to this Board and is subject to Chapter 83A of the General Statutes of North Carolina (NCGS 83A) and Title 21, Chapter 2 of the North Carolina Administrative Code (21 NCAC 02).
2. Respondent York, after being contacted by a client on April 4, 2023, offered and rendered architectural services to said client on a project in North Carolina.
3. Respondent York is not currently licensed with this Board to offer and render architectural services in North Carolina. Respondent, on April 19, 2023, applied for Licensure by Reciprocity.
4. Respondent's action in practicing architecture while not licensed is a violation of NCGS 83A. Respondent contends that she did not intentionally violate North Carolina's Architecture Rules and Laws. Nevertheless, in lieu of further proceedings, Respondent has agreed to enter into this Consent Order.
5. Respondent wishes to resolve this matter by Consent and agrees that the Board staff and counsel may discuss this Order with the Board *ex parte* whether or not the Board accepts this Order as written.

BASED on the foregoing and in lieu of further proceedings under 21 NCAC 02, Section .0600, the Board and respondent agree to the following:

1. Respondent shall, within thirty (30) days from the date this Order is approved by the Board, be issued a licensure to practice architecture in North Carolina as an individual.
2. Respondent shall submit with this order the necessary application and payment to license

3. Respondent shall pay a civil penalty in the amount of \$2,500.00 for practicing architecture without an individual and firm license to do so.
4. Respondent shall reimburse the Board for administrative costs in the amount of \$300.00 related to this Order.
