Form a new North Carolina Professional Limited Liability Company to practice architecture (P.L.L.C.) Attach proposed articles of organization. Note that at least one organizer must be a North Carolina licensed architect.

_____ Obtain a firm license for an out of state architectural corporation (P.C., P.A. Inc.) Attach articles of incorporation as filed in the firm's State of incorporation.

_____Obtain a firm license for an out of state architectural company (L.L.C., P.L.L.C.) Attach articles of organization as filed in the

firm's State of organization.

General Instructions

Complete and return this form to the Firm Compliance Administrator for the NC Board of Architecture and Registered Interior Designers at the above address.

The application fee is \$100 the check should be made payable to NCBA/RID. No refunds.

The Firm Compliance Administrator will issue and return to you the Board's Certificate for Filing which must be sent with your Articles of Incorporation and filed with the North Carolina Secretary of State, Corporations Division. Do not file with the Secretary of State until you have the Certificate for Filing from the Board. The Certificate for Filing as issued by the Board and the Certificate of Authority as issued by the Secretary of State are necessary documents that lead to firm licensure, they do not permit a firm to offer or render architectural services.

ALL CORRESPONDENCE FROM THE BOARD WILL BE SENT VIA E-MAIL.

For out of state LLC or PLLC - The firm name must contain the word "Professional LLC or PLLC or P.L.L.C. If the firm name as used in its home State does not have a professional designation you must use a "doing business as" (d/b/a) name. For example, Doe Architecture, LLC d/b/a Doe Architecture, PLLC.
